



Environmental labelling

As required by the applicable law:

All packaging must be appropriately labeled according to the procedures established by the applicable UNI technical standards and in compliance with the determinations adopted by the Commission of the European Union, to facilitate the collection, reuse, recovery and recycling of packaging, as well as to ensure correct information to consumers on the final destinations of packaging. Producers are also obliged to indicate, for the purposes of identification and classification of the packaging, the nature of the packaging materials used, on the basis of Decision 97/129 / EC of the Commission.

WHAT IS PACKAGING

The definition of packaging refers to:

- a) *packaging: the product, composed of materials of any nature, used to contain certain goods, from raw materials to finished products, to protect them, to allow their handling and their delivery from the producer to the consumer or user, to ensure their presentation, as well as disposable items used for the same purpose;*
- b) *sales packaging or primary packaging: packaging designed in such a way as to constitute, at the point of sale, a sales unit for the end user or the consumer;*
- c) *multiple packaging or secondary packaging: packaging designed in such a way as to constitute, at the point of sale, the grouping of a certain number of sales units, regardless of whether it is sold as such to the end user or the consumer, or whether it serves only to facilitate the replenishment of the shelves at the point of sale. It can be removed from the product without altering its characteristics;*
- d) *transport packaging or tertiary packaging: packaging designed in such a way as to facilitate the handling and transport of goods, from raw materials to finished products, of a certain number of sales units or of multiple packaging to avoid their manipulation and damage to transport, excluding containers for road, rail, sea and air transport.*

TYPE OF PACKAGING USED AT FACCIN GROUP

The products delivered by FACCIN GROUP have the following types of packaging:

- Primary packaging = Not applicable
- Secondary packaging = Not applicable
- Tertiary packaging = transport packaging, the components of which are shown in Table 1



For this type of packaging (transport packaging) the law makes it clear that:

"In order to ensure the correct environmental labeling even of finished packaging sold, directly by the manufacturer, neutral, without graphics or printing, (eg. Transparent bags, non-personalized wrapping) and packaging for transport or tertiary packaging such as film for palletization , pallets, boxes or interlayer in corrugated cardboard, it is necessary to consider a possible alternative to the traditional labeling to be affixed to the packaging itself. [...]"

For the aforementioned packaging, the obligation to identify the packaging material is considered to be complied with, where the manufacturer enters this information on the transport documents accompanying the goods, or on other external media, including digital ones. "

PACKAGING FOR B2B

The guidelines for environmental labeling specify that:

Packaging intended for B2B, for example packaging intended for professionals, or packaging for transport or related to logistic or exhibition activities, may not present the information relating to the final destination of the packaging, but must necessarily include the coding of the composition materials in accordance with Decision 129/97 / EC.

All other information remains, however, voluntarily applicable.

FACCIN GROUP fulfills the provisions by summarizing the necessary information in Table 1 below.

There is also adhesive tape, which cannot be separated manually from the body of the packaging: for this there is no indication in Table 1.
